# F4134 CHAIRMAN

The Council noted and recognised the Special Circumstances of the application contrary to its normal grants policy.

### F4143 ARTICLE 4 DIRECTION – HOUSES IN MULTIPLE OCCUPATION

The Committee was disappointed to note the correspondence from the Cabinet Member for Housing and Planning at Cornwall Council who advised that it was still premature to consider the request for the Article 4 Direction. The Chairman reported he was raising the issue with the local Member of Parliament

### F4144 PUBLIC CONVENIENCE REVIEW

The Town Clerk reported that he had reiterated the stance of the Council to Cornwall Council. That is that the Webber Street Public Conveniences were surplus and ideally be incorporated into a redevelopment of that aspect of the Municipal Buildings, and could the facilities at Prince of Wales Pier, Swanpool Beach, Castle Beach, Gyllyngvase Beach and Maenporth Beach be incorporated into existing Cornwall Council lease arrangements and the facility at Grove Place Car Park be funded from the Car Park revenue given its strategic importance. The report was duly noted.

## F4145 BEACH CLEANSING

The Town Clerk reported that following residents complaints Cornwall Council had confirmed that Gyllyngvase Beach and Swanpool Beach were cleansed to a Grade A standard at peak season. The issue of seaweed and protocols for how it was dealt with was under review.

It was proposed by Councillor Sterratt, seconded by Councillor O'Brien and

#### **RESOLVED** that

- (i) the Council requests Cornwall Council to provide additional, or better placement of existing, litter bins at Gyllyngvase Beach
- (ii) Cornwall Council be requested to expeditiously address the issue of seaweed accumulation at Gyllyngvase and Swanpool Beaches and that the Town Council be permitted to input to the formulation of a seaweed removal policy for Town Beaches
