C4099 **APOLOGIES**

Apologies for absence were received and approved from Councillors Choak (sailing event) and Jewell (family commitment).

C4100 INTERESTS

C4102 TOWN MAYOR'S REPORT

The Town Mayor reported upon his Civic attendances. These included presentation of Jubilee Medals to Officers at Falmouth Fire Station, the Finn Gold Cup Ceremony, Civic Call by the Finnish Navy, Dracaena Centre Lunch with Sir Keith Mills, event at Pendennis Castle, Olympic Torch Community events and Jubilee celebrations.

Further he reported a letter from Sergeant Watts at Falmouth Police thanking the Council and the Town Manager for ensuring Olympic Torch events were successful for the Town. This was endorsed by PCSO McDonnell who felt the event showcased all that was good in Falmouth when all community partners worked together. As a torch-bearer he offered to attend with the torch and support community events if required. Ms Chadwick of Cornwall Council made a similar offer, for which the Town Mayor thanked them both.

C4103 PUBLIC QUESTIONS

Mr Day of Clare Terrace, Falmouth requested if the Council could assist in addressing refuse and litter issues in the Western Terrace area, especially issues of houses in multiple occupation, and those associated with the end of the academic year.

The Town Mayor requested that this question be addressed in the following presentation at Minute C4104.

C4104 REFUSE AND RECYLCING COLLECTION IN FALMOUTH

Mr Wilkins, Accommodation Officer, advised that his role was to assist those students living in the town, and reported that the recent contractual changes for refuse and recycling collection had exacerbated the problems previously identified by Mr Day (Minute C4103). He had walked the area with Councillor Ms Merrett the Council's Environmental Champion to raise awareness and establish the scale of the problem. Students were advised of good practice and they had tried to ensure suitable and sufficient rubbish receptacles were available. They also sought to encourage a more responsible approach when students were vacating properties. Issues were flagged to landlords to address.

Mr Pearson, Student Union President, advised he would be happy to support any measures to address the problems identified, and felt that education and awareness of the issues should be improved.

Mr Collins, Cornwall Council Contract Compliance Officer, explained to the Council the zoning and grades of cleansing for areas of the town and the contractors obligations therewith. Transitional arrangements had proved problematic but now they were more settled the Contractor would be looking to better enforce householder indiscretions. The Council Enforcement Team would take a zero tolerance approach. The tenant and not the landlord would receive the Fixed Penalty Notice. He was pleased to note that the University was working with resident students. He reported upon trials for seagull proof protection for refuse and he hoped this could be extended to Falmouth.

Messrs Wilkins, Pearson and Collins then responded to questions.

Councillor Mrs Hrydziuszka left the meeting during the above presentations.
