### **P3989 APOLOGIES**

Apologies for absence were received from Councillors Body (ill) and Mrs Hrydziuszka (work).

### **P3990 INTERESTS**

Councillor Mrs V E Eva declared an interest in PA02/0635/10/B as she worked in the adjoining premises and was well acquainted with the applicant. She did not speak or vote thereon.

Councillor Jewell declared an interest in P3994 as he farmed land around the proposed diversion of the footpath. He left the meeting during the consideration thereof.

### **P3991 PLANNING APPLICATIONS**

Members considered a revised list of planning applications which had been commented on by the Chairman, under the delegated procedure agreed in accordance with Minute 6/2474 of the meeting held on the 3<sup>rd</sup> April 2000 and amended by Minute P3017.

It was proposed by Councillor Ms Merrett and Councillor Mrs V E Eva

P3994 **HIGHWAYS/TRAFFIC MANAGEMENT/ROAD SAFETY**

Proposed Diversion of part of the footpath 304/44 at 'Stack Point House' in the Parish of Falmouth CP – Section 119 of Highways Act, 1980.

It was proposed by Councillor Mrs V E Eva, seconded by Councillor Ms Merrett and

RESOLVED that the Council objects to the proposal as the diversion is more circuititous and less accessible for users.
