C5477 TOWN MAYOR'S REPORT

The Town Mayor reported a continuing concern in Covid infections locally. He thanked Councillors Edwards and Kirkham for assisting with the distribution of lateral flow tests to local businesses. A local vaccination drop in had been well received on The Moor and he hoped would be repeated. He thanked the Town Team for their work ensuring the safety of the high street and supporting local businesses, as well as having to adapt local events. The council with sickness and isolating requirements had suffered from staffing issues, and he thanked all staff for their efforts and particularly mentioned Sophie Sanders regarding supporting residents attending the Falmouth Information Service.

The Deputy Mayor also reflected on local efforts around Covid measures and business continuity. She gave an overview on outreach work and her busy local case load. Regarding supporting her environmental and Green Corridor works she thanked the Council's Grounds and Facilities Manager for his assistance.

PC Cummins provided an update on community policing and that additional resource would be available to assist dealing with anti-social behaviour on The Moor. Penwerris

Councillor Kirkham updated on the Falmouth place shaping proposals. At Cornwall Council she had been appointed to Chair the Local Government Pension Scheme Committee. She was disappointed that Cornwall Council had refused to consider her housing motion.

Boslowick

Councillor Jewell advised that he had met and toured locally with the Housing Portfolio Holder, social local rental provision was a current priority. The Cornwall Council Local Plan was currently under review. He hoped that there would be consideration on the restriction on second homes. The Climate DPD would encourage sustainability measures and better design in new developments. He was pushing for the provision of the proposed footpath at Swanpool, which was a planning condition. Parking at Swanpool was being looked at. The wall at the Liner development was also being investigated as it was not built to design.

Arwenack

Councillor Magowan reported that he had been engaged in a number of Neighbourhood Overview and Scrutiny Committee and Audit Committee meetings. These have involved setting the work programme for the year and addressing high priority activity. He was liaising with Falmouth Bay Residents Association and other residents regarding ongoing concerns around Boscawen Road and fields, with a recent circus event cancelled due to inadequate risk assessments being in place. Additional work includes a positive relocation of a street trading vehicle and responding to the illegal traveller encampment at the Hornworks in early July. Progress has been made regarding traffic data capture on Pendennis Rise and around the Point to address concerns of residents and conversations continue regarding similar safety concerns around Swanpool Hill.

Covid cases and impact

- With the continuing challenges despite restrictions lifting there are fortnightly meetings with Public Health at Cornwall Council and also NHS staff to discuss what more can be implemented.
- Thank you to the Mayor, Deputy Mayor and Cllr Jayne Kirkham as well as several Town Council staff who have delivered almost 7000 tests to businesses across the town. Businesses were very grateful to receive these to encourage regular twice-weekly testing as a minimum.
- Businesses, the same as individuals are of course able to order direct but we wanted to be doing all we could to tackle the local spike.
- In addition to above we have been pushing for more local vaccination hubs/opportunities to increase the % locally. I am pleased to confirm that Fri 23rd July this will be the case on the Moor, between 10-5.30pm offering the Pfizer jab.
- One of the biggest challenges for the town which is no surprise and happening across the UK is businesses that are opening, then closing, then opening and the obvious impact with lack of staffing if individuals are pinged.

Falmouth Week 6-15th Aug

- A huge amount of work has taken place in a short timescale due to the nature of everything changing at the moment. As with all events everything is very fluid due to Covid however the electronic programme is now up online https://falmouthweek.co.uk/digital-programme/ and you can also download the pdf via the main menu. You can view further detail on both shoreside and sailing activities via www.falmouthweek.co.uk We will be updating this when there are amends/updates.
- Key points as part of the week are as follows: Carnival- Sat 7th Aug 6.30pm (leaves the Recreation Ground), Red Arrows (and the family day through the town) with the Reds display over the bay -Weds 11th Aug 6.15pm, Fireworks- Fri 13th Aug at 10pm (delayed until the Sat if weather poor)
- Falmouth Sailing Week under the umbrella of Falmouth Week will be taking place in the Carrick Roads and also in the Bay, this runs from Sun 8th-Sat 14thAug
- The Moor Piazza has lots going on from the returning large carousel that was here at Christmas a couple of years ago. There is also the simulator, large interactive screen as well as market stalls including the army.

- The Action Sports Tour will be returning to Church Street car park on Weds 11th as part of the Family fun day. There will also be the RNLI day on the Custom House Quay which has developed over the years.
- Then we have the whole series of evening entertainment in the marquee, this starts with the Carnival that is the first Saturday to the ticketed events each night (except the Tuesday) through the week ending with Russell Howard on the following Sunday.
- The big difference for the marquee this year as well as it being re-located to Church Street car
 park is of course Covid and this is being assessed all the time as things are obviously changing
 daily. We work closely with South-West Bars & Events who run the tent and it goes without
 saying that everything is being monitored very closely due to Track & Trace, staff availability,
 possible self-isolation etc.

Tour of Britain Sun 5th Sept

• This is developing for the event and the approximate timings for entering Falmouth on the outskirts are at 1.08pm from Mabe at 1.04pm, Swanpool Road 1.14pm, Castle Drive 1.17pm and over to Penryn by 1.28pm via Melville Road. As you can see it moves through very quickly hence the reason for a big screen at Pendennis Point to broadcast the more of the race plus encouraging lots of bikes with riders of all ages and preferably in fancy dress. The key point is volume to create atmosphere.

16.1 COVID RESTRICTIONS

The Government have lifted the national restrictions and England has moved to Step 4. However cases remain high and are rising nationally and locally. The Council will continue to operate its Covid safety measures regarding its operations and public access to its facilities. Which includes limited hours for the Falmouth Information Service, a continuation of remote working practices, a requirement to wear face masks, ventilation, to remain distanced and sanitise hands. Risk assessments remain as previously reported.

The Council has decided not to convene physical meetings for the time being and will continue with virtual councillor sessions and use of the delegated powers process (Minute C5449).

16.2 CORNWALL COUNCIL ENGAGEMENT

Cornwall Councillor Jordan has sought the views of Town and Parish Councils on a number of engagement and service matters by Cornwall Council. I have discussed this with senior members and a draft Falmouth response is attached to this report that Councillors may wish to further add to before submission.

16.3 COMPLAINTS

Two separate complaints from Mr Needham and Mr Dyer have been processed and concluded under the Council's procedure both relating to the consideration of planning applications.

16.4 FINANCIAL FORECAST

Pursuant to Minute F6547 of the Finance and General Purposes Committee meeting, attached is the Forecast Report from the Responsible Financial Officer.

16.5 SCHOOL CROSSING PATROLS

Cornwall Council have enquired if the Council will assist the funding of the School Crossing Patrol provision at Albany Road. Approximately £3,000 per annum. It was removed from core funding several years ago, and the Town Council declined a request to support its continuation at that time. It has been funded by a parent and the King Charles School Parent Teacher Association since then.

Councillor Kirkham is establishing whether the Killigrew Road SCP (Falmouth Primary School) will be replaced following retirement.
