LSC95 CORNWALL COUNCIL SRTREET TRADING APPLICATION

A New Application for Street Trading, The Shukin Seafood Shack, Cliff Road
The Committee considered a new application for The Shukin Seafood Shack to trade on
Cliff Road (site 1) where a previous trader had surrendered his consent. Proposed hours of
trading during the summer 1130am to 8pm and during the winter 1130am to 3pm. To sell
hot and cold seafood dishes and hot and cold locally produced drinks from 3m x 3m gazebo
which will later become a small catering unit (no bigger than 12ft long). The Gazebo to be
fronted in shack style wood and serving counter made out of recycled surfboards.

It was proposed by Councillor Gray, seconded by Councillor Mrs Davies and

RESOLVED that the Council refuse the application to trade on Cliff Road (site 1) as the Gazebo is not appropriate for the site, is not a mobile vehicle and is too big and the Council has concerns that it would be left on site over night.

It was further proposed by Councillor Mrs Brock, seconded by Councillor Body and

RESOLVED that Cornwall Council be asked to confirm exactly where the sites are on Cliff Road as traders usually arrived late and set up in whichever space was available. Clarification would enable the Town Council to determine a Policy for the Seafront.
