LSC104 **MINUTES**

It was proposed by Councillor Mrs Davies, seconded by Councillor Ms Merrett and

RESOLVED that the minutes of the meeting of the Committee held on 12<sup>th</sup> October 2015 be agreed as a correct record of the proceedings and signed by the Chair.

LSC105 **CORNWALL COUNCIL STREET TRADING**

The Committee considered the Falmouth Street Trading Renewal applications for 2016.

It was proposed by Councillor Body, seconded by Councillor Ms Merrett and

RESOLVED that

- (i) in principle the renewal requests be supported
- (ii) the Licensing Authority be requested to provide a map of the renewal locations and to request the applicants not to move outside of the designated pitches this was a particular issue with the Cliff Road consents.

LSC106 **CORNWALL COUNCIL PREMISES LICENCE APPLICATIONS**

- (i) New application for entertainment/late night refreshment/alcohol for 29A High Street, Falmouth

The applicant advised that he wished to revert the premises to a restaurant/brasserie. Alcohol sales would stop at 11.30 with premises shutting at midnight (thirty minutes later for both on Friday and Saturday nights). The late night refreshment was merely to serve non-alcoholic drinks until closure of the premises. Music would be live (piano) and recorded and merely incidental to the restaurant. Offsite alcohol sales would be sealed bottles of wine only.

The Police Licensing Officer reported complaints with a previous licence when the premises had been used as a music venue. The current low level music proposed would be acceptable. She was also satisfied with the offered conditions.

It was proposed by Councillor Body, seconded by Councillor Gray and

RESOLVED that the licence application as submitted be supported.

(ii) Proposed amendments to a variation to Licence for Picnic, Ground Floor, 14 Church, Falmouth

The Chair referred to the recent objections to the variation by the Town Council and Police. The applicant had amended the variation request in consultation with the Police and the matter has been dealt with by written representations. She requested the Committee to ratify that.

The Police Licensing Office confirmed she was satisfied with the amendments proposed.

It was proposed by Councillor Mrs Brock, seconded by Councillor Gray and

RESOLVED that the Committee ratify the decision to support the application subject to the following conditions:

- (i) Provision of Late Night Refreshment to cease daily at 0100 hrs.
- (ii) Premises closed to the public at 0100 hrs.
- (iii) Addition of a condition that reads: 1 SIA door supervisor will be employed at the premises from 2300 hrs daily, if the premises is to open after 2300 hrs.
- (iv) Addition of a condition that reads: CCTV will be installed, operated and maintained at the premises. Images will be stored for a minimum of 14 days. There will be suitable trained staff on duty at all times who can download CCTV images if required by Police or an authorised officer of Cornwall Council.
- (v) Addition of a condition that reads: All litter/rubbish emanating from Picnic will be cleared daily within 100m radius of the premises following closure of the premises.

There being no further business the Chairman declared the Meeting closed at 5.40pm.
