C4689 PRESENTATION FROM FALMOUTH AND EXETER UNIVERSITIES

Professor Carlisle reminded the Council of the need for and development of the Universities. Cornwall was still amongst the lowest of Higher Education (HE) places in the UK. Overall the strategy was to improve and grow the economy of Falmouth. Growth was still needed and Cornwall was only one of two regions in the UK identified as economically less developed. HE would help build and regenerate the economy. Building up of HE assets was the key to transforming Falmouth and Penryn and wider afield. Access to HE was also vital to Cornish youth, with a target that 25% of students to be Cornish.

They were attempting to address concerns over housing. There was accommodation for new arrivals and Truro and Helston were interested in developing student accommodation. They were also looking at local development options with further development on the Penryn Campus in 2018.

Professor Hosken outlined the community support Exeter University provided, enhancing events and cultural offer. The University wished to be a good neighbour and students and staff good citizens, being socially responsible. He would work together to ensure growth plans were collaborative and inclusive. He outlined the recent profile and national success enjoyed by Exeter University which would grow by 400 students in the next five years (50 students in 2017 all housed on campus).

He totally supported the Article 4 Direction proposal and was looking at housing solutions outside of Falmouth. He would work with specialist providers of student housing and look at increasing parking on campus.

Mr Lane outlined the current engagement with Local Plan and Neighbourhood Plan and that proposals brought forward were those of developers and not the Universities.

The representatives from the Universities then responded to Members questions and a full debate ensued, during which Councillors S D Eva and Mrs V E Eva left the meeting.

The Chairman called a brief adjournment for members of the public and University representatives to clear the Council Chamber.
