# LSC170 APOLOGIES

An apology for absence was received and approved from Councillor Ms Merrett (ill).

#### LSC171 INTERESTS

Councillor Gray declared a registerable interest in the Street Trading Applications considered in Minute LSC174 as he owned the café at Castle Beach and left the meeting during the consideration of these items.

#### **LSC172 MINUTES**

It was proposed by Councillor Gray, seconded by Councillor Mrs Davies and

RESOLVED that the minutes of the meeting of the Committee held on 27<sup>th</sup> March 2017 be agreed as a correct record of the proceedings and signed by the Chair.

## LSC173 CORNWALL COUNCIL LICENCES

(1) New Application for Sale of Alcohol, Swanpool Beach Café, Falmouth
The Chair advised that the application was to permit the sale of alcohol for consumption on site from Monday to Sunday from 1800 hours to 2300 hours for the summer only from 1st May to 30th September and extended opening hours for the pop up restaurants to 2300 hours.

The Chair reported the observations of the Police Licensing Officer who supported the application.

It was proposed by Councillor Body, seconded by Councillor Gray and

RESOLVED that the Council supports the license application as this is a well run establishment.

(2) New Application for Entertainment, Late Night Refreshment and Sale of Alcohol, Cotswold House, 49 Melvill Road, Falmouth

The applicant reported the application was for the provision of recorded music Monday to Sunday (24 hours), the provision of late night refreshment Monday to Sunday from 2300 hours to 0500 hours and the sale of alcohol for consumption on site from Monday to Sunday (24 hours) for guests of the guesthouse only.

The Chair reported the observations of the Police Licensing Officer who raised no objections to the application.

It was proposed by Councillor Gray, seconded by Councillor Body and

RESOLVED that the Council supports the license application.

Councillor Mrs Davies requested that it be noted that she abstained from voting on this application.

## LSC174 STREET TRADING APPLICATIONS

(1) <u>Application for Street Trading Consent by Kelly Marie Galsworthy at Boscawen Road</u> The Chair advised that the application was to permit Kelly Marie Galsworthy (Kelly's Kitchen) to sell refreshments from a trailer at Boscawen Road, Falmouth, on Sundays from 0800 hours to 1700 hours from April 2017 to December 2017.

It was proposed by Councillor Body, seconded by Councillor Mrs Davies and

RESOLVED that the Council recommends refusal of the application due to the location being in a greenbelt, residential area and this would set a precedent.

(2) <u>Application for Street Trading Consent by Kelly Marie Galsowrthy at Cliff Road</u> The Chair advised that the application was to permit Kelly Marie Galsworthy (Kelly's Kitchen) to sell refreshments from a trailer at Cliff Road, Falmouth on Saturdays from 0800 hours to 1700 hours from April 2017 to December 2017.

It was proposed by Councillor Mrs Davies, seconded by Councillor Body and

RESOLVED that the Council recommends approval of the application with an amended trading time of 1000 hours to 1700 hours as consistent with other traders in the area.

The Chair advised that the applicant had asked if the Committee would consider an application to trade by Kelly Marie Galsworthy at Cliff Road on a Sunday from April 2017 to December 2017 if they recommended refusal of the Boscawen Road application. The Committee confirmed that this would be considered once the application had been received.

### LSC175 COMPLAINT

The Committee noted a complaint received regarding noise nuisance and off-premises drinking at Five Degrees Below, Grove Place, Falmouth.

It was proposed by Councillor Mrs Brock, seconded by Councillor Body and

RESOLVED that the Council write to the owners of Five Degrees Below asking them to address these issues.
