LSC176 APOLOGIES

Apologies for absence were received and approved from Councillors Mrs Brock (work) and Ms Merrett (ill).

LSC177 INTERESTS

Councillor Gray declared a registerable interest in Minute LSC180 application by Kelly's Kitchen to trade in Cliff Road, as he operated a café at Castle Beach. He left the meeting for that item and Councillor Body took the Chair, albeit the Committee were inquorate for that item.

LSC178 MINUTES

It was proposed by Councillor Body, seconded by Councillor Gray and

RESOLVED that the minutes of the meeting of the Committee held on 10th April 2017 be agreed as a correct record of the proceedings and signed by the Chair.

LSC179 CORNWALL COUNCIL LICENCES

New Application for Entertainment/Alcohol Licence, 60 Church Street, Falmouth.

It was noted that the applicant's details had become transposed on the application and therefore had not been invited to the Committee.

It was proposed by Councillor Mrs Davies, seconded by Councillor Body and

RESOLVED that subject to the approval of the Police Licensing Officer and compliance with their suggested conditions then the Council does not object to the licence application.

LSC180 STREET TRADING APPLICATIONS

(1) Application for Street Trading Consent : The Moor Piazza : Mr Adrian Charles Williams (t/a Willians Whippy)

The applicant advised that he wished to trade selling ice creams, ice lollies and cold drinks on the Moor from 10am to 6pm Monday to Sunday from May 2017 to December 2017. He responded to questions.

It was proposed by Councillor Body, seconded by Councillor Mrs Davies and

RESOLVED that the Council would not wish to see any further street trading consents granted for The Moor Piazza as it potentially stymied market and event operations for the site, as well as interfering with access to public buildings. The Council retains its policy that only one consent (currently taken up) and appropriately sited should be the limit for consents on The Moor Piazza.

(2) Application for Street Trading Consent : Cliff Road : Miss Kelly Marie Galsworthy
(t/a Kelly's Kitchen)

An amended application was considered to sell refreshments from a trailer at Cliff Road on Saturdays and Sundays from 1000 hours to 1700 hours May to December. It was noted that the original application to trade at Boscawen Road had been withdrawn.

The Committee became inquorate and proceeded to make an informal comment on the application :

The Council would not support the amended application as there was a saturation of vendors, and other providers, in the vicinity.

There being no further business to transact the Chairman declared the Meeting closed at 5.35pm.
