LSC187APOLOGIES

Apologies were received and approved from Councillors McCarthy (who wished to withdraw from the Committee) and Mrs Minson (Civic duty).

LSC188 INTERESTS

None received.

LSC189 MINUTES

It was proposed by Councillor Eva, seconded by Councillor Saunby and

RESOLVED that the minutes of the meeting of the Committee held on 22nd May 2017 be agreed as a correct record of the proceedings and signed by the Chair.

LSC190 CORNWALL COUNCIL LICENCES

(1) <u>Minor Variation to Licence</u>, <u>Warehouse Bistro</u>, <u>38B Arwenack Street</u>, <u>Falmouth</u> The Applicant advised that she wished to amend the licence to allow for additional outside seating incidental to the restaurant. She felt 16 to 18 seats would be provided and the right of way/access maintained. The landowner and neighbour had been consulted and raised no objections.

It was proposed by Councillor Saunby, seconded by Councillor Eva and

RESOLVED that the Council does not object to the minor variation subject to access through the site being maintained and not obstructed.

(2) New Entertainment/Alcohol Licence for The Ope, 5 High Street, Falmouth
The Applicants wished to serve hot and cold drinks and food Monday to Saturday 0800 to
0000 hours and Sunday 0800 to 2300 hours. Supply alcohol Monday to Sunday 1200 to
2300 hours. It was their intention to open Monday to Wednesday 0800 to 1600 hours and
Thursday to Sunday 0800 to 2300 hours. Recorded non-amplified music to be played
indoors only. Capacity no more than 20 people.

The Police Licensing Officer had recommended conditions including operating a Challenge 25 policy, improvements to CCTV etc.

It was proposed by Councillor Ms Morgan, seconded by Councillor Eva and

RESOLVED that the Council does not object to the licence subject to the Applicants meeting the conditions required by the Police Licensing Officer.

(3) New Entertainment/Late Night Refreshment/ Alcohol Licence for the Chain Locker, Quay Street, Falmouth

The Applicant advised that he wished for live music, recorded music, performances of dance and supply of alcohol. Music only Monday to Sunday 1200 to 0000 hours. Supply of alcohol 0800 to 0100 hours. Open to the public Monday to Sunday 0800 to 0130 hours. Whilst the licence covered the whole premises only parts would be used at various times.

The Police Licensing Officer had raised no issues as the premises had been operational for some years with no issues, the Licensee was experienced and would be joining Pubwatch.

It was proposed by Councillor Eva, seconded by Councillor Ms Morgan and

RESOLVED that the Council raises no objection to the Licence application.

(4) <u>Minor Variation to Licence for the King's Head, 32 Church Street, Falmouth</u> The Applicant wished to vary the licence to extend recorded music Monday to Thursday until 0100 hours. Friday to Saturday to 0200 hours. Sunday 0000 hours. This would better regularise the licence as opening hours would be Monday to Thursday until 0130 hours, Friday to Saturday until 0230 hours.

Following refurbishment the licenced area was totally separate to the upper residential floors which were adequately soundproofed and protected. Friday evenings would be an over 25's night. Signage would be replaced and the premises renamed as The Kings.

The Police Licensing Officer advised that there were no issues. The licence did not extend existing supply of alcohol hours, merely music. She was satisfied with the sound management works. The Licencee was experienced and chaired Falmouth Pubwatch.

It was proposed by Councillor Ms Morgan, seconded by Councillor Eva and

RESOLVED that the Council does not object to the Licence application.
