(1) New Alcohol Licence, 10B High Street, Falmouth

The Council were disappointed that the applicant did not attend to present their application. The Town Clerk reported that the Police Licencing Officer had recommended an improved condition regarding staff training and added a Challenge 25 Policy, which the applicant had agreed to.

RESOLVED that subject to the applicant observing the conditions recommended by the Police then the Council would raise no objection to the application.

Councillor Saunby requested that his name be recorded as having abstained from voting as the applicant had not provided sufficient information to determine the application.

(2) <u>Variation to Licence</u>, <u>The Kitchen</u>, <u>4 Old Bakery Yard</u>, <u>High Street</u>, <u>Falmouth The Committee were disappointed that the applicant did not attend to present their application</u>. The Town Clerk reported that the Police Licencing Officer raised no objections, but advised she did not speak for the Environmental Health Service at Cornwall Council who should comment on possible noise.

RESOLVED that subject to the satisfaction of the Environmental Health Service at Cornwall Council then the Council raises no objection to the application.

Councillor Parker requested that his name be recorded as having voted against this decision as the applicant had not provided sufficient information regarding reducing noise nuisance.

LSC240 STREET TRADING APPLICATION

Application for Street Trading Consent by Shibasaki Awesome Hair

The applicant advised that his mobile hairdressing service did not require street trading consent however he wished to sell hair styling products to his customers hence the need for the application.
