POLICE REPORT FOR COUNCIL MEETING - 17th SEPTEMBER 2018

The Police Cadets have had another successful summer with coverage of parades, the carnival, Falmouth Week, assisting students at Falmouth University upon arrival, the Civic Parade yesterday, leaflet drops and speed watch initiatives.

Speedwatch initiatives are being worked on for the area. PCSO Ellie Grey is working with Sarah Corber, the citizens in policing co-ordinator for the area on local speed watch initiatives as well as exploring the possibility of neighbourhood watch.

Falmouth Homeless Action Group are meeting on October the 1st and have invited volunteers who are currently active in the area in an effort to co-ordinate aid and help for our local homeless and to structure what it is we should and shouldn't be doing.

There have been a couple of fires recently, both of which the police are investigating and aware of. They are isolated incidents.

There will be targeted work with our partner agencies around the arrival of students in Falmouth for the new academic year and prior to Freshers week. These visits are made with the University, Environmental Health, Community Safety Officer, Fire service etc to educate students on both keeping themselves safe and well and how they should conduct themselves whilst residing in the area also.



Falmouth Community Fire Station Town Council Report

The following outlines a brief overview of July and August 2018, focusing on three core areas of Protection, Prevention & Response.

1. Protection

Watches fulfil their part in the protection arm of the Fire and Rescue Service by undertaking visits at commercial premises. Many larger premises either have in-house staff trained in fire safety or choose to buy in the services of a consultant. Either way that person is ensuring their employer is fulfilling its legal and moral duty to protect staff and customers from the risk of fire. However, many smaller businesses have very little knowledge of their responsibilities and the laws concerned with fire safety. Cornwall Fire and Rescue Service aims to raise the standards within these organisations by visiting, informing and advising on fire safety. Our simple aim for these small businesses is that they fulfil their minimum legal obligations and look to write into their business plan a work schedule which brings their property up to a standard which better reflects the widely accepted best practice.

- a. Tactical Information Files for higher risk premises
 The watches completed 8 site visits, from The Fabrication Workshop at A&P to RFA
 Tideforce which is currently under refit in dry-dock. A TIF visit is an information gathering
 exercise where watches collate and check the data held about commercial premises or on
 visiting ships and vessels that may be in dock for a considerable period. These are
 selected as they are either deemed to be at greater risk of a fire breaking out, or should a
 fire break out, they pose a greater risk to the public or firefighters attending an incident.
 The TIF data is stored on each fire engine, and at Fire Control, however firefighters are
 expected to have a broad knowledge of the layouts and risks presented by each of our
 TIF premises.
 - An example of the sort of premises covered by a TIF would be a large manufacturing company, or a medium-large hotel.
- b. Operational Fire Safety Visits for lower risk premises
 The watches completed 4 site visits, in the Falmouth & Penryn area. An OFSV is a brief visit carried out on premises whose risk is deemed to be more generic. The aims are to identify the use and occupier of the building, and to inform and advise the occupier of their legal responsibility to protect from the risk of fire. In practice this means the crews carry out a brief and informal survey of the building; checking that the occupier has carried out a Fire Risk Assessment; taken steps to reduce the risk of fire; and taken appropriate steps to protect occupants should a fire break out.

 An example of the sort of premises covered by an OFSV would be any commercial property not covered by a TIF; eg. a small shop or industrial unit

2. Prevention

At a watch level this area is covered by Home Fire Safety Checks and prevention talks to community groups.

a. Home Fire Safety Checks During this quarter, crews carried out 96 HFSC, in and around the Famouth and Penryn area. Notable visits were held in Denyer Court and Grovehill Crescent in Falmouth. This is a free service we offer to all residents, be they home owners or tenants. The crew base their advice around a booklet entitled Fire Safety in the Home, but tailor the information specifically to the hazards identified during their visit. The crew also carry free smoke detectors to fit if appropriate. b. Community Engagement During the past months, crews were involved in numerous separate community events. Most notable of these was the Fire Station Open Day where various activities and fundraisers were held with a large number of the local community attending. Also Black Watch continue to undertake their work working with Dementia groups in the Dementia Garden initiative. In the summer months crews patrolled the beaches at various times

engaging and raising awareness of BBQ and bonfire safety with members of public.

3. Response

This area is self-explanatory however members of the general public are often unaware of the breadth of incidents the Fire & Rescue Service are trained and equipped to respond to. The following list summarises only the types of incidents we attended during the quarter:

During this period incidents were divided 78% by day and 22% by night.

4. Summary

The above overview gives an impression of the range of work that is undertaken by Falmouth Community Fire station on a day to day basis. Alongside the public-facing Protection, Prevention, and Response duties are the internal and preparatory tasks; obviously for each incident or inspection there is the inevitable paperwork trail to complete, all the equipment on our seven response vehicles needs to be regularly tested and maintained, and to ensure the crews are able to fulfil their duties the watches undertake regular training drills and courses. Add to all this the work undertaken by the Phoenix team and the volunteer community work and hopefully it is clear that your local fire station continues to be a busy hub in the community for Community Safety and Protection.

Falmouth Week

Another hugely successful week despite juggling the weather on a few occasions.

Pink Wig

Pink Wig as we discussed on the last report was sold out. To see the sea of Pink filling the whole of Church Street from start to finish is always a sight to behold. It was a very positive start to the week.

Carnival

The Falmouth Marine Band organised activities at the Recreation Ground and the majority of things were moved indoors before the carnival took place later in the day.

The weather did make this challenging and a big thank you to everyone that helped ensure it was a safe and well run event. Clearly numbers were reduced for participation and crowds, but there was still a great turnout.

Red Arrows/ Family Day/ RNLI Fun on the Quay/ Action Sports Tour

The Red Arrows changed to a 'Flat Display' due to the cloud base and there were many things we had to do behind the scenes, more than usual ahead of the display. I changed a few operational points for people leaving Gylly beach and that worked well although we can always have more marshals and safety vehicles. The Harbour Master/RNLI and support boats from the Yacht Clubs kept a clear line for spectator boats to be within.

Travel- This worked much better for 2018 and while there will always be delays the queuing system at Falmouth Docks work well and the majority of passengers used this station instead of Falmouth Town with the short platform.

Opening up additional car parking space as well as various comms via Pirate FM and BBC Radio Cornwall all helped.
