LSC284 INTERESTS

Councillor Parker declared a non-disclosable interest in Minute LSC286 (2) as his sons business is next door to Star Glazers. He left the meeting during the consideration of that matter.

LCS286 CORNWALL COUNCIL LICENCES

(1) Variation to License, The Moth and the Moon, 31 Killigrew Street, Falmouth The applicant requested a variation to include the first floor of the premises for licensable activities and to amend condition for the requirement of door staff.

Ian Vasey advised the Committee that the previous reasons for refusal had now been addressed and the Licensing Officer was now satisfied with acoustic tests. The first floor would be used for seating only with speakers but no live music. One speaker had been removed from the party wall although the acoustic test results did not require this. Although licensed until 1am the premises usually closed at 12am therefore door staff were not necessary and Coast to Coast had offered a radio service and furthermore staff were going to be trained on door security.

Councillor Kirkahm entered the meeting at 510pm.

It was proposed by Councillor Gillett, seconded by Councillor Morgan and

RESOLVED that the Council raises no objection to the application.

(2) Grant of License, Star Glazers, 17 High Street, Falmouth

The applicant requested a License for the sale of alcohol on the premises only.

Christine Walker advised the Committee that Star Glazers is a Pottery Painting Café with two hour booking slots available on site to paint and glaze for up to 30 people with two members of staff. The premises is not a regular bar and operates from 10am to 11pm but often closes earlier. A TENS is currently used for popular events such as Paint and Prosecco but the events are becoming increasingly popular.

It was proposed by Councillor Morgan, seconded by Councillor Bonney and

RESOLVED that the Council raises no objection to the application.
