LCS294 CORNWALL COUNCIL LICENCES

(1) Market Street, Falmouth

The applicants advised that they were refurbishing the former Watermans premises that had ceased trading in 2015 and fallen into disrepair. It would be an all-day eatery with external decking open 0900 to 2200 hours every day, with alcohol served with meals for on-site and off-site sales. There would be hot and cold food takeaway. The license would be for live music, recorded music and supply of alcohol Monday to Sunday 0900 to 2200 hours.

The Town Clerk reported the Police Licensing Officer raised no objection.

It was proposed by Councillor Eva, seconded by Councillor Parker and

RESOLVED unanimously that the Council raises no objection to the license application.

(2) Oggy Oggy Pasty Shop, 50 Arwenack Street, Falmouth

The Chair was disappointed the applicants had not attended to support their application. The Town Clerk reported that the Police Licensing Officer did not object to the application but recommended the challenge 25 condition. The License application sought on-sale of alcohol Monday to Sunday 0800 to 2200 hours.

It was proposed by Councillor Gillett, seconded by Councillor Parker and

RESOLVED that the Council raises no objection to the license application subject to on-sales only, alcohol only served with food and challenge 25 scheme being implemented.

Councillor Saunby requested that his name be recorded as having abstained from voting in regard to this application.
