LSC308 APOLOGIES

Apologies for absence wer received and approved from Councillors Bonney (family commitment) and Gillett (family commitment).

LSC309 INTERESTS

None received.

The Town Clerk advised that there was no interest for Councillors in the Boo Koos application as they did not gain from the application and no interest was declared.

LSC310 MINUTES

RESOLVED that the minutes of the meeting held on 29th July 2019 be agreed as a correct record of the proceedings and signed by the Chairman.

LSC311 CORNWALL COUNCIL LICENCES

Grant to License, The Heir and Bell Ltd, 4 Old Brewery Yard, High Street, Falmouth
The applicant advised that license was sought for provision of recorded music
Monday to Sunday 1200 hours to 0000 hours indoors only and supply of alcohol
Monday to Sunday 1200 hours to 0000 hours with outdoor service to cease at 2200 hours
then doors and windows closed to minimise noise. Drinking up time to be 2340 hours
with challenge 25 in operation, staff training and CCTV.

The Town Clerk reported that the Police Licensing Officer proposals had been agreed by the applicant.

It was proposed by Councillor Eva, seconded by Councillor Parker and

RESOLVED that the Council raises no objection to the licence application.

Grant to License, Boo Koos, Ground Floor, The Post Office, The Moor, Falmouth
The applicant advised that License was sought for supply of alcohol Monday to Saturday
0900 hours to 2230 hours and Sundays 0900 hours to 2200 hours. The premises to be
open 0900 hours to 2300 hours Monday to Saturday and 0900 hours to 2230 hours on
Sundays. A similar Boo Koos establishment was already in operation in Helston with no
licensing issues and CCTV and staff training would be mandatory.

The Town Clerk reported that the Police Licensing Officer raised no objections.

It was proposed by Councillor Eva, seconded by Councillor Saunby and

RESOLVED that the Council raises no objection to the licence application. The Council notes on its response to the Licensing Authority that the applicant was a tenant of the Council.

Councillor Spargo entered the meeting at 530pm.

Minor Variation to License, Five Degrees West, 7 Grove Place, Falmouth

The applicant advised that minor variation was sought to delete conditions 'there shall be no customers entry or re-entry between 0130 and when the premises closes to the public on Tuesday, Friday, Saturday and Sunday mornings' and 'There shall be a system in place to ensure that after 0100 hours each day, no more than ten customers are allowed in the outside area at the front of the premises at any time'. Tuesday to be deleted in place of Thursday which was an error on the original approval. These were no longer relevant to the nature of the night time economy and caused congestion for patrons queing to get in and out.

The Town Clerk reported that the Police Licensing Officer advised that Environmental Health should comment rather that the Police as it was a noise issue. There was also an objection from Cornwall Councillor Kirkham.

It was proposed by Councillor Eva, seconded by Councillor Morgan and

RESOLVED that the Council refuses the application as it considered there was still a need for the condition: 'there shall be no customer entry or re-entry between 0130 and when the premises closes on Thursday, Friday, Saturday and Sunday mornings' which includes the Tuesday to be deleted in place of Thursday. The Council does recommend that there shall be a system in place to ensure that after 0100 hours each day, no more than twenty customers are allowed in the outside area at the front of the premises at any time, ideally to be seated.
