LSC360 CORNWALL COUNCIL LICENCES

The Games Room, 12 Market Street, Falmouth

Members duly considered variation to license for extension to opening hours and regulated entertainment. Opening hours to increase from 12pm until 130am Monday to Sunday. The bar will close at 1am with doors closed by 130am and recorded music will cease at 1am.

The Manager explained the variation which is to increase the business hours to meet demand. The Games Room is not part of the clubbing scene and the increased hours would allow for staggered leaving times. All staff are trained with no under 18's permitted after 7pm, 'Think 25' is in operation, door staff will be employed from 8pm to 1am on Saturdays and Sundays and membership of the Pubwatch Scheme to continue.

It was noted that the Police Licensing Officer raised no concerns as the existing premises was well run and caused no issues.

It was proposed by Councillor Eva, seconded by Councillor Young and

RESOLVED that the Council raises no objection to the variation to licence application subject to 12 month trial to ensure the increased hours do not result in a negative impact on the cumulative impact zone.

Kernow Wine Ltd, 21 Killigrew Street, Falmouth

Members duly considered grant for licence for sale of alcohol including online sales. Supply of alcohol Monday to Sunday 1100 hours to 2100 hours. Online sales delivery

between 1100 hours to 2100 hours only. Christmas Eve until 2230 hours and New Years Eve until 0030 hours. Opening hours Monday to Sunday 1100 hours to 2130 hours, Christmas Eve 2300 hours and New Years Eve 0100 hours.

The applicant advised on the conditions of the grant for licence for new wine bar and shop that would primarily cater for local residents and tourists with high class wine and food on offer. The wine bar to cater for 20 covers only including free local delivery and online sales. Regular hours to be 11am to 9pm daily with no late night license except for Christmas Eve and New Years Eve.

It was noted that the Police Licensing Officer raised no concerns as all licensing conditions had been met.

RESOLVED that the Council raises no objection to the grant of licence application.
