### LSC371 MINUTES

It was proposed by Councillor Eva seconded by Councillor Cole and

RESOLVED that the minutes of the meeting held on 29<sup>th</sup> November 2021 be agreed as a correct record of the proceedings and signed by the Chairman.

### LSC372 CORNWALL COUNCIL

The Orgia, 43 Church Street, Falmouth

Members duly considered grant to license for sale by retail of alcohol Mondays to Fridays 0800 hours to 2230 hours (open 0800 to 2300 hours), Saturdays 0800 hours to 2300 hours (open 0800 to 2330 hours) and Sundays 0800 hours to 2230 hours (open 0800 to 2300 hours). Christmas Eve and New Years Eve 0800 hours to 0100 hours (open 0800 to 0130 hours). Service will cease for the outdoor area at 2130 hours.

The Chair reported that the Police Licensing Officer raised no concerns.

It was proposed by Councillor Eva, seconded by Councillor Cole and

RESOLVED that the application is refused as the Council are concerned that the application will impinge on the CIZ and furthermore the applicant was not present so the Council felt unable to make an informed decision.

NB: Following Licensing Officer advice the resolution was amended on 15<sup>th</sup> December 2021 to the following:

The Licencing Committee further considered the application, and taking into consideration how it would sit within the CIZ (Comunalative Impact Zone), feel that the application is far too close to other licenced premises within the CIZ, which already has a negative impact on residents living in the immediate area, and would add to current noise and anti-social behaviour, which is already common in this location, which is currently well served by licenced premises.

Kings Head Hotel, Church Street, Falmouth

Members duly considered variation to license to increase the opening hours, sale of alcohol on the premises and recorded music on Wednesday nights only. Wednesday opening hours to increase from 0900 to 0130 hours to 0900 to 0200 hours, sale of alcohol hours to increase from 1000 to 0100 hours to 1000 hours to 0145 hours and recorded music to increase from 1000 to 0000 hours to 1000 to 0200 hours.

The applicant explained that Wednesdays have become a busy student night in Town and during the last 8 weeks he had been submitting Tens Licences for the late night opening which had proved to be busy. Mangoes cannot accommodate all the students therefore the Kings later opening hours take students off the street and prevent the long ques outside Mangoes.

The Chair reported that the Police Licensing Officer raised no concerns.

It was proposed by Councillor Eva, seconded by Councillor Young and

RESOLVED that the Council raises no objection to the variation to the license.

Falmouth Farmer's Market Pitch, The Moor, Falmouth

Members duly considered grant to license for sale by retail of alcohol at Farmers Market adjacent to Sue & Petes pitch on Thursdays and Saturdays 0900 hours to 1800 hours.

The Chair reported that the Police Licensing Officer raised no concerns and reported that the applicant had been trading under a Tens License and wished to formalise the License.

It was proposed by Councillor Clegg, seconded by Councillor Rowe and

RESOLVED that the Council raises no objection to the grant to license.

Koala Karlous, 23 Killigrew Street, Falmouth

Members duly considered Pavement Licence to allow furniture on the "highway" to be used for the consumption of food, alcohol and drink until 30 September, 2022.

The applicant explained the need for outdoor seating during the pandemic which will encourage patrons not to loiter inside the premises.

It was proposed by Councillor Cole, seconded by Councillor Young and

RESOLVED that the Council raises no objection to the Pavement License subject that the applicant does not encroach out of the limitations of his pitch to ensure that the pavement is easily accessible to pedestrians.

There being no further business to transact the Chair declared the Meeting closed at 5.55pm.
