C5643 DEPUTY MAYOR'S REPORT

The Deputy Mayor updated on her civic and community event attendance. She had assisted the environmental 'Yellow Fish' Campaign, led the Falmouth Pride Parade, participated in schools' jubilee events and Hate Crime and ASB measures, military day at Royal Cornwall Show and had toured the Harbour Office and facilities. The beach toy exchange, repurposed telephone box on Cliff Road was now set up.

C5645 MAYORAL CHARITY - GEORGIA'S VOICE

Sophie Aldridge advised that she was a founder of the charity, a legacy of her daughter who had taken her own life in 2020. The charity provided support groups for young women aged 18-25 with mental health concerns. There were two trained facilitators who ran wellbeing activities and talking therapies. There were ten groups running and a further three being established. A charity shop was in Killigrew Street, Falmouth. She thanked the mayor for his support. In response to questions, she advised that over one hundred young women had so far benefited with groups sized between four and six, although the Falmouth group was over twenty. There were options for participants to transition out and provide support for others.

Arwenack

Councillor Magowan provided an update on matters relating to his electoral division. Cornwall Council had slipped back on progress towards its environmental and carbon-neutral targets, and he felt needed better communications on this with residents. He updated on recent planning appeals at Bells Court and Sheldon House.

Boslowick

Councillor Jewell provided an update on matters relating to his electoral division. He had been reappointed to Chair the Central Planning Committee and updated on some planning applications. He was concerned that a footpath to be provided by the Linden Homes development was still not provided, nor was play and green space areas required by the Wainhomes development permission. The 20-mph speed limit pilot was starting to be rolled out locally.

Trescobeas and Budock

Councillor Saunby provided an update on matters relating to his electoral division. The Acacia and Oakfield one-way traffic system was being consulted on; he would like to see a fuller scheme provided. Overgrown hedgerows were an issue and he had dealt with a significant number of housing queries.

Penwerris

Councillor Kirkham provided an update on matters relating to her electoral division. Invasive plant species on verges was an issue. She served the Adult Care Scrutiny Committee and was worried regarding the poor availability of dentists in Cornwall and Falmouth. She was looking at external licensing requirements for Houses in Multiple Occupation. She Chaired the Falmouth Place Shaping Board and was hopeful that national Levelling up and Shared Prosperity Funding would be available for Falmouth schemes.

General points

- There is an array of new businesses opened up over the last couple of months which is good to see. While any town will have 'churn' of some businesses there continues to be positive interest in many sites.
- There are many things the Town Team have been working but I have focused on the recent Jubilee and also the upcoming shanty and classics event as they will take place very shortly.

Queen's Jubilee

- This was a huge success with so many positive comments across the various events. From the Beacon Lighting to Jubilee in the Park. The street parade was well attended with lots of support from the public.
 - Colin and the team did a great job for the Tea Dance at the Pavilion including dressing the venue in very effective red/white and blue drapes.
 - The Street Party was an absolute brilliant atmosphere, we were lucky as the weather in the early morning was heavy rain as well as rain forecast throughout the day that did not materialise. Over 800 registered for the street party which took place in Market Street.

I would like to say a big thank you to everyone that helped out over various events, it was a huge amount of work and effort by so many.

Shanty Festival

- Straight off the back of the Jubilee the shanty festival is fast approaching on the 17th-19th June. This promises to be a significant event especially coming off the back of Covid and no physical event for the last couple of years.
- There is lots of information via www.falmouthseashanty.co.uk so I will not repeat here as well but a few key points below:
- There are 70+ plus groups performing from across the UK and internationally.
- The performances will be across 25+ venues across the town including the main stages. These are: The Greenbank Stage, The Seven Stars Stage, The Pier Stage, Church Street

- car park stage (new for this year), The Seasalt Custom House Quay Stage and Skinners Events Square Stage as well as all the other venues.

- On Church Street car park as well as the new stage that will be on the lower car park section there will be an Arts & Crafts Market on the top section. Some of the traders are existing businesses within the town but are also trading in this location. That helps fund the stage and also other requirements.
- The Market on the Moor will take place from the Thurs-Sat inclusive due to the festival taking place.
- There is a reusable festival cup again this year which is available from various venues as part of the festival for £2. Thanks to Seasalt for the design of the cup.
- Huge thank you to all the sponsors/partners of the festival including the main sponsors Skinners Brewery & Seasalt Cornwall and key sponsors The Greenbank Hotel, Falmouth Town Council & Falmouth BID. South West Bars & Falmouth Events have also played a major role in this event taking place.
