Recommend approval however the Elms currently look in good health and are certainly not very exposed as suggested, in fact they are well protected on all sides and do not look at all likely to fail, however as these Elms are likely to succumb to Dutch Elm disease the Council have no problem with them being removed/replaced but the suggestion that a single standard Ash for replacing these 6 trees is not sufficient compensation, also Ash are now under threat from "Ash Dieback" disease so the replacement would quite likely not survive to anywhere near maturity. It is noted that the closely planted group of 6 Elms are tall and spindly as they are struggling for light as the group should have been thinned but the garden shading issues are mainly from the height of the main house and the wall they are planted against. The Council recommends replanting with x3 standard Birch over the same span as the existing trees as an option Yellow, Paper and grey Birch have reasonable salt tolerance and would add to the amenity and interest to the garden.
